Investments are focused in developed markets, and where practicable, foreign currency exposure is hedged to the Swiss Franc. The Sub-Fund is actively managed without reference to any benchmark.

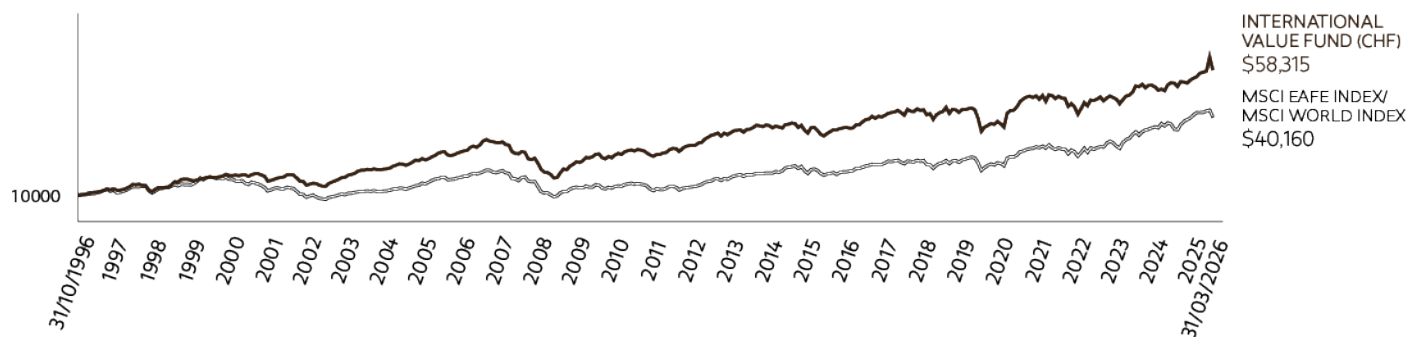

COMMENTARY & MARKET OUTLOOK (All facts & figures are as of 31/03/2026, unless otherwise noted)

The seemingly indefatigable advance in global equity markets over the last few years faced macroeconomic headwinds in the First Quarter of 2026, as equities declined amid heightened geopolitical tensions, including military conflict involving Iran and resulting disruptions to global oil supply, which increased volatility and investor unease. The war-related spike in oil prices dampened the very recent outperformance of non-U.S. equities relative to their U.S. counterparts; nevertheless, non-U.S. equity markets, as represented by the MSCI EAFE Index, still significantly outperformed U.S. equities for both the quarter and the 12 months ending 31 March. As we write in mid-April, a cease-fire in the Iranian conflict has helped to spark a rebound in global equity indices, led by an unusually robust rally in U.S.-based high technology companies, though it remains to be seen whether market sentiment will revert to the AI-related concerns that had emerged prior to the outbreak of hostilities.

Against that backdrop, the Tweedy, Browne International Value Fund (CHF) advanced 1.54% in the first quarter of 2026, comparing favorably to its benchmark, the MSCI World Index Hedged to CHF, which declined 4.24%.

Several holdings across Energy, Industrials, Information Technology, Health Care, and Materials contributed meaningfully. TotalEnergies was the largest contributor, advancing as crude oil prices surged following conflict in the Middle East and the closure of the Strait of Hormuz. Within Industrials, CNH Industrial, BAE Systems, and UniFirst contributed across machinery, aerospace and defense, and commercial services. Samsung Electronics drove the contribution in Information Technology. In Health Care, Roche, Novartis, and GSK contributed through pharmaceuticals, with Envista Holdings adding from health care equipment. In Materials, Sol S.p.A. and Fuso Chemical led within specialty chemicals, while FedEx contributed through air freight and logistics. Geographically, South Korea was the largest contributor, followed by France and Italy, with Britain also positive. By market capitalization, large- to mid-cap and mid-cap holdings drove the bulk of returns.

On the other side, Roche (Genussschein) was the largest detractor, even as the company's ordinary shares contributed positively. Alphabet, Berkshire Hathaway (Class A), and Subaru detracted, as did CVS Group and Diageo. Berkeley Group, Fresenius, Safran, and Prudential each detracted modestly. Germany and Hong Kong were the primary geographic detractors.

Currency hedging contributed meaningfully to results. The euro, British pound, South Korean won, and Japanese yen weakened against the Swiss franc, and the hedges largely offset those translation losses. The U.S. dollar appreciated against the franc, modestly reducing the benefit from dollar-denominated holdings; overall, currency was a net positive.

Transaction activity was measured. The Sub-Fund initiated six new positions, each at prices we believed offered a meaningful discount to intrinsic value. Auto Trader Group operates the UK's dominant digital marketplace for buying and selling automobiles; Bunzl is a British distribution and outsourcing business serving a wide range of industries with essential consumable products; Jazz Pharmaceuticals is a Dublin-based biopharmaceutical company focused on treatments for rare diseases in oncology, neuroscience, and sleep disorders; Nihon Nohyaku is a Japanese manufacturer of agricultural chemicals and crop protection products; Springer Nature is a global academic and scientific publisher whose portfolio includes the Nature journals and Springer; and T. Hasegawa is a Japanese producer of flavors and fragrances used in food, beverages, and consumer products. The Sub-Fund also added to Johnson Service Group.

On the sell side, Atmus Filtration Technologies, DBS Group Holdings, and Kanadevia were exited as prices approached or exceeded our estimates of intrinsic value. TotalEnergies and Samsung Electronics were trimmed following appreciation, and Coltene Holding was also reduced. The portfolio continues to reflect a patient, long-term orientation, with turnover driven by valuation discipline rather than market movements.

We have been encouraged over the past year by the nascent resurgence in value-oriented equities, particularly smaller and mid-cap non-U.S. companies where informed corporate insiders have often been meaningful buyers of their firms' shares. Prior to the outbreak of hostilities in late February, the proverbial "puck," to borrow from Wayne Gretzky, appeared to be moving toward where we had "skated," reflecting what we view as a long overdue shift in equity market leadership. However, since the onset of conflict in Iran, relative momentum has once again, at least in the near term, gravitated toward U.S.-based technology stocks. Despite this war-induced rotation, we remain hopeful that the fundamental conditions underpinning the earlier shift in sentiment remain largely intact and continue to point to a more promising long-term opportunity set for patient, value-oriented investors.

The Sub-Fund may not be publicly sold in any other jurisdiction and may not be offered or sold in the US.
